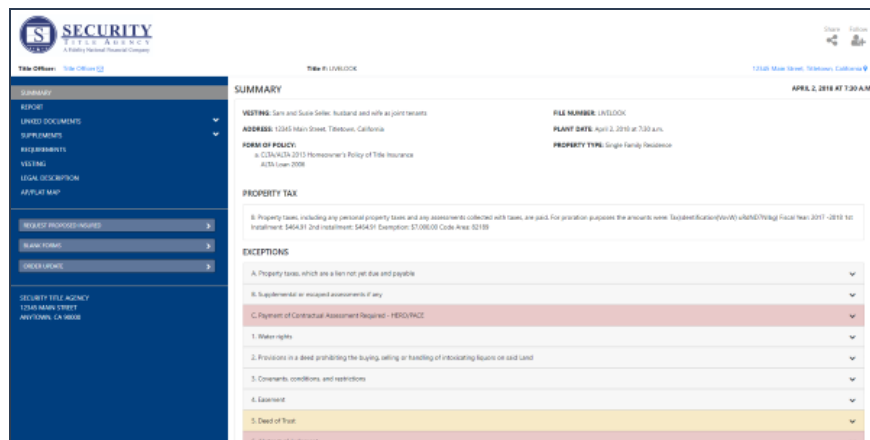

3. The Company's liability and obligation is limited by and this Commitment is not valid without:
